### Background

In the years 1997–2002, he was a freelance lawyer at Cottbus district court and in the years 2000–2002 he was approved as a lawyer at Dresden district court. He has been approved to practise as a lawyer at Potsdam district court since 2003. In the same year, Konrad Schampera was registered in the list of foreign lawyers at the district bar association in Wrocław.

From 2000 to 2002, he was the managing partner of an international law firm in Wrocław.

He is the arbitration judge at the arbitration court of the German–Polish Chamber of Foreign Trade in Warsaw.

Konrad Schampera is a member of the supervisory board of the "KRZYZOWA" FOUNDATION FOR EUROPEAN AGREEMENT. The Krzyzowa Foundation was established in the process of Polish–German reconciliation to promote European understanding. Established in 1990, the International Youth Meeting House in Krzyzowa serves as a meeting place for Polish and German youth and has a European and intergenerational character. ### Expertise
